### SUBJECT:

Flash: Transmission Shift and Driveability Enhancements

#### **OVERVIEW:**

This bulletin involves reprogramming the Transmission Control Module (TCM) with the latest available software.

## **MODELS:**

2017 (B1) Jeep Renegade

NOTE: This bulletin applies to vehicles within the following markets/countries: LATAM.

NOTE: This bulletin applies to vehicles built on or after October 04, 2016 (MDH 1004XX) and on or before January 27, 2017 (MDH 0127XX) equipped with 1.8L I4 E-Torque Engine E100 (Sales Code EBF) and 6-Spd Aisin F21-250 Gen 3 Auto Trans (Sales Codes DF7).

# SYMPTOM/CONDITION:

The customer may describe that when the ignition is turned on, the odometer numbers flash.

#### **DIAGNOSIS:**

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in TechCONNECT, verify all related systems are functioning as designed. If Diagnostic Trouble Codes (DTCs) or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If the customer describes the symptom/condition listed above or if the technician finds the DTC, perform the Repair Procedure.

#### REPAIR PROCEDURE:

NOTE: The Powertrain Control Module (PCM) must be updated to the latest available software at the conclusion of this repair procedure. Refer to all applicable published service bulletins for detailed repair procedures and labor times regarding updating the PCM software.

NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

- 1. Reprogram the TCM with the latest software. Detailed instructions for flashing control modules using the wiTECH Diagnostic Application are available by selecting the application's "HELP" tab.
- 2. Perform a proxi configuration after the TCM reprogram. Refer to the detailed service procedures available in DealerCONNECT> TechCONNECT under: Service Info>08 Electrical/ 8E Electronic Control Modules/Standard Procedure.
- 3. Clear any DTCs that may have been set in any modules due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.
- 4. Verify the PCM is programmed with the latest available software. Refer to all applicable published service bulletins for detailed repair procedures and labor times regarding updating the PCM software.

## **POLICY:**

Reimbursable within the provisions of the warranty.
