Service Procedure

- 1. Remove the driver footrest. Refer to Driver Footrest Replacement in SI.
- 2. Remove the left front side door sill garnish molding. Refer to *Front Side Door Sill Garnish Molding Replacement (Left Side)* in SI.

- 3. Lift the front floor carpet to access the footrest mounting bracket area.
- 4. Inspect the harness branch from main body wiring harness to accelerator pedal. Verify the branch is not pinched underneath footrest mounting bracket.

• If the branch is not pinched under the footrest mounting bracket, no further action is required. Reinstall the components in the reverse order of removal.

• If the branch is pinched under the footrest mounting bracket, proceed to step five.



- 5. Remove the foot rest mounting bracket fastener.
- 6. Inspect the harness for damaged wires. If damage is found, repair the harness as required. Refer to *Wire to Wire to Wire Repair* in SI. This harness repair will be covered as a warranty claim.

- 7. Route the harness branch as shown, ensure the branch is not trapped under the mounting bracket.
- 8. Reinstall the foot rest mounting bracket fastener **Tighten:** 6N.m (53 lb.in)
- 9. Reinstall the components in the reverse order of removal.

Dealer Responsibility
