## APPLICABLE MODEL(S)/VINS

2016 Mazda6 vehicles with VINs lower than JM1 GJ \*\*\*\*\*\* 454155 (produced before October 01, 2015)

2016 CX-3 vehicles with VINs lower than JM1 DK \*\*\*\*\*\* 118705 (produced before October 05, 2015)

2014-2016 Mazda3 (Japan built) vehicles with VINs lower than JM1 BM \*\*\*\*\*\* 293850 (produced before October 01, 2015)

# DESCRIPTION

Some vehicles may exhibit the active driving display opening/closing improperly as described below:

- It does not open or close when the ignition is turned ON or OFF.
- The display operation does not fully open/close.
- It closes and then opens by itself while the vehicle is moving.

This concern may be caused by voltage fluctuation to the active driving display which activates pinching detection.

Customers having this concern should have their vehicle repaired using the following repair procedure.

# **REPAIR PROCEDURE**

1. Verify customer concern.

2. Replace the Active Driving Display. Refer to MGSS online Workshop Manual:

- Mazda6 ACTIVE DRIVING DISPLAY REMOVAL/INSTALLATION
- CX-3 ACTIVE DRIVING DISPLAY REMOVAL/INSTALLATION
- Mazda3 ACTIVE DRIVING DISPLAY REMOVAL/INSTALLATION

**NOTE:** For Mazda3 vehicles with VINs lower than JM1BM\*\*\*\*\*259081, replace both the Active Driving Display with the modified one and the instrument cluster (speedometer) with the latest one. There is NO compatibility between the modified display and early instrument clusters.

Mazda3 VINs	Replace:
JM1BM*****259080 and before	The Active Driving Display and the instrument cluster (speedometer) with the latest one. <b>NOTE:</b> If the instrument cluster is replaced, refer to SPEEDOMETER REPLACEMENT PROCEDURE TSB for further information.
JM1BM*****259081 and later	Only the Active Driving Display.

3. Verify repair.
