

CONDITION SUMMARY:

SITUATION:

An issue has been identified on certain vehicles within the listed Affected Vehicle Range where the steering gear tie-rod end ball joints have not been suitably sealed from exterior weather conditions. Water or other contaminants may be able to enter the steering gear tie-rod end ball joints which could lead to the ball joint developing a knocking noise after long exposure.

ACTION:

Retailers are required to **HOLD** affected new vehicles that are within your control and refrain from releasing the vehicles for **new vehicle sale** pending completion of the Workshop Procedure detailed in this Technical Bulletin. Unsold vehicles should have this performed as part of the Pre-Delivery Inspection (PDI) process but **must** have it completed prior to vehicle handover to the customer.

Affected vehicles already in the hands of customers should be updated at the next available opportunity.

Use the Jaguar Land Rover claims submission system to make sure that a vehicle is affected by this program prior to undertaking any rework action.

At the time of confirming a booking for vehicle repair, ensure that **all** outstanding Recall and Service Actions are identified to ensure the correct parts are available and adequate workshop time is allocated for repairs to be completed at one visit.

Warranty claims must be submitted quoting the Program Code together with the relevant Option Code. The SRO and parts information is included for information only. The Option Code(s) that allows for the drive in/drive out allowance can only be claimed if the vehicle is brought back into the workshop for this action alone to be undertaken.

Repair procedures are under constant review and therefore times / prices are subject to change; those quoted here must be taken as guidance only. Use the Jaguar Land Rover claims submission system to obtain the latest repair time.

This program is valid for a limited time only. Warranty claims with a repair date prior to the **31 August 2019** closure date must be submitted or payment within 30 calendar days of completion of the repair.



Raise and support the vehicle (see TOPIX Workshop Manual section 100-02: Jacking and Lifting).



Inspect the tie-rod bellow clamp for a yellow paint mark indicating that the repair has previously been completed.


- If the identification mark is present, **go to Step 6**.
- If the identification mark is not present, **go to Step 3**.



Clean rust and visible contaminants from the area shown in the illustration.


- 1 Use a scribe to clean the area between the retaining cap joint.
- **2** Use a suitable tool to clean the retaining cap surface.

The area must be dry before application of the sealing wax.



Apply the sealing wax to the tie-rod end retaining cap.

- **1** Make sure there is sufficient wax applied to seal the retaining joint cap.
- **2** Make sure the wax coats all of the retaining cap surface.



Apply yellow paint mark to the tie-rod bellow clamp to indicate completion of the repair.

6	Perform Steps 2-5 to the left tie-rod.

Z Lower the vehicle (see TOPIX Workshop Manual section 100-02: Jacking and Lifting).

8 Release the vehicle.

If a repair has been carried out, the vehicle should not be washed for at least 4 hours to allow the wax time to dry.
