



SUBJECT: Gapping of Rear Quarter Panel Garnish DATE: 06/18/18

INTRODUCTION:

This bulletin outlines changes made to the rear quarter panel wheel arch garnish to eliminate gapping between the inner edge of the trim and the vehicle body as shown in the images below.





PRODUCTION CHANGE INFORMATION:

To address this condition, changes have been made to the retaining tab at the rear of the garnish. Details of the changes are provided in the Part Information below. The changes were phased into production at two VIN breaks:

• Change #1: **J*200103**

• Change #2: **J*225689**



PART INFORMATION:



- Change #1 (Original): Added 1 thickness of non-woven material to the rear-most retaining tab to enhance garnish retention. These parts were produced between 5/18/2017 and 8/23/2017.
- Change #2 (Improved): Stack 4 thicknesses of non-woven material to the tab to further enhance retention and eliminate gapping. The tab was also extended by 1.5mm. These parts were produced on and since 8/24/2017.

NOTE: The part numbers for the garnishes have not been changed.

SERVICE PROCEDURE / INFORMATION:

The service procedures for replacing the garnish remain unchanged. Always refer to the applicable Service Manual and review the full requirements of the repair being performed. The Service Manual procedures contain information critical to performing an effective repair the first time and every time. This includes but is not limited to: important SAFETY precautions, proper inspection criteria, necessary special tools, required processes and related one-time-use parts needed for a complete and lasting repair. Customer satisfaction and retention starts with performing quality repairs.
