

This Service Information bulletin announces the standardization of the IG2 and ACC relays used on the models listed. Both of these relays are located on the back (front facing) side of the passenger compartment fuse box (F/B) as shown in the image below.



PART INFORMATION:

The new part number for both of these relays is: 82501AL000.

NOTE: Only these 2 relays have been changed to the new part number. Other locations requiring part number 82501AG070 will continue to use that part number as specified in the parts catalog.
