- 2017 Mazda6 vehicles (with Dual Type Full Auto A/C) with VINs lower than 153042 (produced before December 1, 2017)


# DESCRIPTION

Some customers may complain about an unpleasant odor (such as one may notice with a home freezer) coming from the A/C in hot weather (95°F / 35°C or above). This could be caused by improper control logic for the climate control unit that leaves the A/C compressor on too long and results in a frozen evaporator and an unpleasant odor. To correct this issue, the control logic for the climate control unit has been modified.

**NOTE:** This TSB is not for musty/mildew odors. For those types of odors, refer to TSB for AIR CONDITIONING MUSTY / MILDEW ODOR.



Odor particles (1) are absorbed in condensed water (2) at the evaporator surface (3). The odor particles comes from exhaust gas, sweat, cosmetics, foods, fragrances, animals, etc.



When frozen, some of the odor particles (1) are released from the ice (2) at the evaporator surface (3) because the ice cannot hold all of them, which result in the unpleasant odor (4).

# **REPAIR PROCEDURE**

1. Verify concern. The odor should be present when:

- The ambient temperature is 95°F (35°C) or above.
- The climate control is set to AUTO mode.
- 10 minutes after the A/C is turned on and the blower speed has decreased (fan speed 2 in AUTO mode).
  - If the concern can be reproduced, replace the climate control unit with a modified one according to the instructions on MGSS.
    - Mazda3 (CLIMATE CONTROL UNIT REMOVAL/INSTALLATION [FULL-AUTO AIR CONDITIONER]).
    - Mazda6 (CLIMATE CONTROL UNIT REMOVAL/INSTALLATION [FULL-AUTO AIR CONDITIONER]).
  - If the odor is present under different conditions than mentioned above, this TSB does not apply. Follow normal diagnosis according to the instructions on MGSS.

2. Verify repair.
