INTRODUCTION:

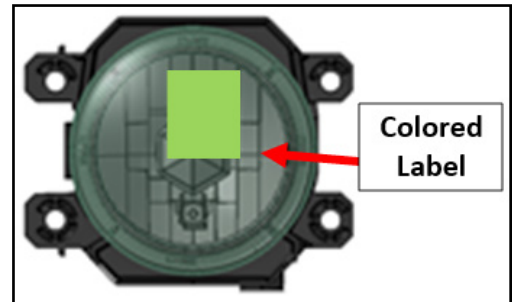
This Service Information bulletin announces a change made to the lens portion of the fog light assembly. The new lens has optimized light distribution characteristics while remaining interchangeable with the original type.

PRODUCTION CHANGE INFORMATION:

There is no production change information as this information only applies to service (replacement) parts.

PART INFORMATION:

These new fog light assemblies are identified by a colored label affixed to the back side as shown here. The labels are either pink, green or white depending on the application.
