Service

- 1. If only **DTC B200FF1** (internal malfunction) is logged, then replace the camera control module.
- 2. If both **DTCs B200FF1** and **B200FF2** are logged, then replace the camera control module.
- 3. If only DTC B200FF2 (internal malfunction) is logged, proceed as follows:
 - Delete the DTC.
 - If the DTC is not logged again, return the vehicle to the customer. It is <u>not necessary</u> to replace the front camera.
 - If the DTC stays active or is logged again, then replace the camera control module.

UNote:

Claims with a replaced camera control modules which only had the DTC B200FF2 once may be denied.


