# Subject: Further Extension of Warranty Period for Crack of Cylinder Block on JB424 and A6B424 models (Campaign code: 99-ZF)

This letter is to inform you that warranty period is furthermore extended to **20 years (unlimited mileage)** for the crack of cylinder block (Campaign code: 99-ZF) on JB424 and A6B424 model vehicles which were notified by the attached letter ABE-ZF-140110-R1.

## Extended Period

The warranty coverage for the cylinder block has been modified and the new extended period is **20 years (unlimited mileage)** instead of 7 years or 170,000 km (102,000 miles).

Affected Vehicles No changes

<u>Warranty Reimbursement Information</u> No changes

In order to ensure the satisfaction of customer, SMC decided to extend the warranty period longer for the cylinder block originally installed at factory.

If customers have paid for repairs before this notification, the customers may be eligible for full or partial reimbursement. Reimbursement for claims may be excluded when adequate evidence is not provided.

## Subject: Warranty Extension For Crack Of Cylinder Block In JB424 And A6B424

This letter is to inform you of a warranty extension for the crack of cylinder block on JB424 and A6B424 model vehicles.

Suzuki Motor Corporation (SMC) has determined that, due to potential residual stress in the casting process of cylinder block, crack might occur at the bottom of the thread for the cylinder head bolt. In this condition, coolant will leak from water jacket, and then it comes out of the cylinder block. As a result, water temperature increase because of lack of coolant in the engine cooling system. Please refer to the following pictures for understanding the condition of the crack.



To ensure the satisfaction of customers, SMC has decided to extend the warranty for the cylinder block on JB424 and A6B424 model vehicles. Details of this warranty extension are explained in the next page.

## Extended Period

The warranty coverage for the cylinder block is being extended to 7 years or 170,000 km (102,000 miles) whichever comes first, from the date of retail sale or when first placed in service as a demonstrator.

## Potentially Affected Vehicles

(1) Model

JB424 (Grand Vitara) and A6B424 (Kizashi)

(2) Production Period From June 2, 2008 to February 25, 2010

NOTE:

Some vehicles are not eligible for the warranty extension even though the production date is within the production range above.

Please refer to the VIN list, which was attached as ANNEX1 on our previous letter Ref No. ABE-ZF-140110 of Jan 10, 2014 since there is no change in the list.
