**Issue:** Some 2019 F-Super Duty vehicles equipped with a 6.7L engine built on or before 21-Aug-2018 may exhibit an illuminated MIL with DTC P205B stored in the powertrain control module (PCM).

Action: Follow the Service Procedure steps to correct the condition.

**Warranty Status:** Eligible Under Provisions Of New Vehicle Limited Warranty Coverage And Emissions Warranty Coverage Warranty/ESP coverage limits/policies/prior approvals are not altered by a TSB. Warranty/ESP coverage limits are determined by the identified causal part and verified using the OASIS part coverage tool.

## Service Procedure

1. Check the vehicle build date. Was the vehicle built on or before 21-Aug-2018?

(1). Yes - proceed to Step 2.

(2). No - this article does not apply. Refer to the Powertrain Control/Emissions Diagnosis (PC/ED) Manual for normal diagnostics.

- 2. Using the appropriate Ford diagnostic scan tool or equivalent, retrieve DTCs. Is P205B stored in the PCM?
  - (1). Yes reprogram the PCM using the latest software version of the appropriate Ford diagnostic scan tool.
