The specific (12) involved vehicles are marked "open" on the Investigate Vehicle History screen in GM Global Warranty Management system. This site should always be checked to confirm vehicle involvement prior to beginning any required inspections and/or repairs.

Condition	Certain 2019 model year Chevrolet Silverado and GMC Sierra vehicles may have a front half shaft that missed the induction hardening on the inboard splines. Improperly heat treated front half shafts would have a shorter durability term. In the event a half shaft may fracture, there are expectations that noises
	would emanate from the front corner suspension region and continued use may cause damage to ancillary components.
Correction	Dealers are to replace both front half shafts, deform removed half shaft and scrap appropriately.

#### **Service Procedure**

Replace both front wheel drive half shafts. Refer to Front Wheel Drive Half Shaft Replacement – Left Side and Front Wheel Drive Half Shaft Replacement – Right Side in SI.
