SUBJECT: FRONT SEATBACK FRAME REPLACEMENT (SC173)

This bulletin provides the procedure to replace the front driver and/or passenger seatback frames in certain 2019MY Kia Optima vehicles, manufactured from December 13, 2018 through January 2, 2019. The upper side member connection area on one side of the front seatback frame may have been improperly welded and may detach as a result. If the weld detaches, the driver or front seat passenger may hear a noise coming from the area and/or may experience slight discomfort when seated.

Before conducting the procedure, verify the vehicle is included in the list of affected VINs.

Vehicles will be identified in WebDCS as requiring SC173B, SC173L, or SC173R.

FRONT SEATBACK FRAME REPLACEMENT (SC173)

Replacement Procedure:

- 1. If necessary, use a Memory Saver to retain or record all radio presets.
- 2. Disconnect the negative (-) battery cable.




3. Determine per VIN whether the vehicle requires both (SC173B), only driver (SC173L) or front passenger (SC173R) seatback replacement, and then replace the driver <u>and/or</u> front passenger seatback frame(s) by referring to the "Body (Interior and Exterior) → Front Seat → Front Seat Frame Assembly → Repair procedures" chapter in the applicable Shop Manual on KGIS.



Removal of the seat cushion is not necessary.

 Confirm proper operation/adjustments and ensure no warning lamps are illuminated. Restore radio presets, if necessary.
