To reiterate the (X41) Warranty Extension for the Airbag Clockspring Assembly on 2007MY Jeep Wranglers as previously communicated in WB D-11-63. (December 21, 2011)

NOTE: The Warranty Extension coverage period is 10 years or 150,000 miles (*whichever occurs first*) under the Basic Limited Warranty.

ACTION:

This bulletin supersedes Warranty Bulletin D-11-63. Please disregard this previous bulletin and ensure adherence to this new publication.

Always check DealerCONNECT >VIP to verify if a vehicle is involved in this Warranty Extension. A vehicle involved in this Warranty Extension will display an *(X41) Clockspring* message in VIP. If no (X41) coverage message displays in DealerCONNECT > VIP, no further action is required on your behalf.

All technicians should familiarize themselves with Service Bulletin 08-119-15 before replacing the Airbag Clockspring Assembly on referenced vehicles. This Service Bulletin has been released to assist all dealers in the proper diagnosis and replacement of the Airbag Clockspring Assembly.

NOTE: In some cases the <u>clockspring may be requested to be returned</u> to the Quality Return Center. Dealers are advised to always follow the Warranty Parts Return Documentation procedure per the Warranty Administration Manual <u>and</u> hold all parts until the claim is paid and the disposition is established.













The Global Claim System (GCS) will only honor the extended warranty coverage on the labor operation number(s) listed in Service Bulletin 08-119-15.

This letter is to inform you that the warranty period (3 years or 36,000 miles) on your Wrangler's clockspring has been extended to 10 years or 150,000 miles, whichever occurs first. This extended clockspring warranty coverage applies to select model year 2007 Wranglers.

We are extending the warranty period on your clockspring because some of the affected vehicle population may experience an airbag lamp illumination caused by a steering column clockspring issue. If vour vehicle is operating properly, there is nothing you are required to do.

If you are experiencing the condition as described in this warranty extension (within the 10 year or 150,000 mile period), simply contact your dealer to schedule a service appointment. Remember to bring this letter with you to your dealer. Please make sure to store this letter with your vehicle's other warranty information for future reference. The warranty extension applies to the above components only; the other terms and the "What's Not Covered" items of your warranty remain the same as stated in your Warranty Information book.

If you have already paid for the replacement of your airbag clockspring, you may be eligible to receive a reimbursement. You may complete the enclosed Customer Reimbursement Claim Form and send your original receipts, invoices and/or repair order to the following address for reimbursement, your claim will be acted upon within 60 days of receipt:
