	A dealer may also state they are unable to obtain a replacement EBCM at this time through GM Partech.			
Cause	All EBCM's that were in stock at GM CCA have been placed on stop sale and are being returned to the supplier to be remanufactured again due to this known sold connection concern. Correction:

Dealer will need to contact Partech and create a SPAC case and wait for GM CCA to receive Parts. If a dealer obtains a part from another dealer, it may also set the C0265 as the dealer had received that part prior to GM CCA recalling EBCM's to send back to the supplier. Dealers are not to contact TAC for assistance as they cannot assist with getting parts any sooner than a SPAC case.
