PURPOSE:

To announce a warranty extension on the 9 Speed 948TE FWD/AWD Automatic Transmission (Sales Codes DFH or DFJ) or a 9 Speed 9HP48 Automatic Transmission (Sales Code DF5) on the following vehicles:

- 2015 Chrysler 200 (UF)
- 2015 Jeep Renegade (BU)
- 2015 Ram ProMaster City (VM)
- 2014 2015 Jeep Cherokee (KL)

Affected Vehicles:

This warranty extension bulletin applies only to the following vehicles:

- BU vehicles equipped with a 2.4L I4 Multiair Engine (Sales Code ED6) with a 9-SPD 948TE FWD/AWD Auto Trans (Sales Codes DFH).
- 2014 MY KL vehicles equipped with a 2.4L I4 Multiair Engine (Sales Code ED6) or 3.2L V6 24V VVT Engine (Sales Code EHB) with a 9-SPD 948TE FWD/AWD Auto Trans (Sales Codes DFH or DFJ).
- 2015 MY KL vehicles equipped with a 2.4L I4 Multiair Engine (Sales Code ED6) or 2.4L I4 Zero EVAP M-AIR Engine (Sales Code ED8) or a 3.2L V6 24V VVT Engine (Sales Code EHB) with a 9-SPD 948TE FWD/AWD Auto Trans (Sales Codes DFH or DFJ).
- UF vehicles equipped with a 2.4L I4 Multiair Engine (Sales Code ED6) or 2.4L I4 Zero EVAP M-AIR
 Engine (Sales Code ED8) or 3.6L V6 24V VVT Engine (Sales Code ERB) with an 9-SPD 948TE FWD/AWD
 Auto Trans (Sales Codes DFJ) or an 9-SPD 9HP48 Auto Transmission (Sales Code DF5).
- VM vehicles equipped with a 2.4L I4 Multiair Engine (Sales Code ED6) and a 9-SPD 948TE FWD/AWD Auto Trans (Sales Code DFH).

NOTE: This warranty extension coverage period is extended to 6 years or 100,000 miles from the vehicle's In-Service Date, whichever occurs first.



















TIMING:

Effective Immediately

ACTION:

Always check *DealerCONNECT or WiADVISOR VIP* to verify if a vehicle is involved in a warranty extension. A vehicle involved in this warranty extension will display an **(X80) 9 Spd Transmission** message in VIP. If no (X80) coverage message displays in VIP, the vehicle is not in the scope of this warranty extension and no further action is required on your behalf.

All technicians are required to familiarize themselves with Service Bulletin 21-025-19 before replacing the 9 Speed 948TE FWD/AWD Automatic Transmission (Sales Codes DFH or DFJ) or the 9 Speed 9HP48 Automatic Transmission (Sales Code DF5) on select vehicles. This Service Bulletin has been released to assist all dealers in the proper diagnosis and replacement of the 9 Speed 948TE FWD/AWD Automatic Transmission (Sales Codes DFH or DFJ) or a 9 Speed 9HP48 Automatic Transmission (Sales Code DF5).

The Global Claim System (GCS) will honor the warranty extension coverages on the standard warranty labor operation number(s).
