

SUBJECT: DTC P173B- Auto Start-Stop System Inoperative **DATE:** 07/30/19

INTRODUCTION:

This bulletin announces availability of a new CVT electric oil pump developed to address DTC P173B: ELECTRIC FLUID PUMP (CVT) PERFORMANCE. The related customer concern describes the Auto Start Stop warning lamp flashing and the system becoming inoperative under certain circumstances. When Auto Start/Stop is inoperative, the vehicle operates like a traditional vehicle not equipped with this feature. The new pumps contain revised judgement logic to eliminate false illumination of the warning lamp.



PRODUCTION CHANGE INFORMATION:

This bulletin will be revised with the starting VIN when it becomes available.

PART INFORMATION:

The part number for the new Oil Pump Assembly is **30726AA001**.

REMINDER: Always order the most up-to-date replacement parts based on the specific VIN being repaired.

SERVICE PROCEDURE / INFORMATION:
