





Enhanced Utility Warranty - \$50 labor on accepted claim Bendix will also provide freight for return of chambers

Continue to process warranty claims through Bendix System – (upcoming "leakage within spec" video)
Special freight instructions will be provided (for chambers only – other products will not be processed)
High rate of rejected claims may result in loss of pre-paid freight for dealership

Part Compensation will continue to be processed within approximately 30 days from part receipt
Enhanced Labor compensated to dealers quarterly outside the system – based on accepted claims
