



Service Procedure



1. Inspect the brake pipe near the steering column as shown. If the brake pipe is secured properly in the clip as shown, no further action is required.



• If the brake clip is missing, install a brake clip.

- If the brake pipe is not secured in the clip, inspect the brake pipe for damage caused by rubbing or contact against the steering shaft as shown by the arrow. If there is no damage, place the brake pipe back in the clip as intended.
- If the brake pipe shows signs of contact or rubbing, replace the entire brake pipe. Refer to *Front Brake Pipe Replacement Right Side (LSY)* in SI.
