SUBJECT:

Flash: Radio Frequency Hub Module (RF-HUB) Updates

OVERVIEW:

This bulletin involves reprogramming the RF-HUB with the latest software available.

MODELS:

RAM 1500 Pickup

- NOTE: This bulletin applies to vehicles within the following markets/countries: NAFTA.
- NOTE: This bulletin applies to vehicles built on or after October 06, 2018 (MDH 1006XX) and built on or before October 29, 2019 (MDH 1029XX) equipped with SiriusXM[®] Guardian, 1-YR Trial (Sales Code RSK).

SYMPTOM/CONDITION:

The customer may describe the following:

• Uconnect remote function inoperable when using the phone App

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If Diagnostic Trouble Codes (DTCs) or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. If any vehicle not on the VIN list exhibits the symptom/condition, perform the repair.

REPAIR PROCEDURE:

NOTE: Install a battery charger to ensure battery voltage does not drop below 13.2 volts. Do not allow the charging voltage to climb above 13.5 volts during the flash process.

NOTE: If this flash process is interrupted/aborted, the flash should be restarted.

- 1. Does the RF-HUB have the latest software already installed?
 - YES>>> This bulletin has been completed, use inspect LOP (18-19-12-9P) to close the active RRT.
 - NO>>> Proceed to Step 2.
- 2. Reprogram the RF-HUB with the latest software. Detailed instructions for flashing control modules using the wiTECH Diagnostic Application are available by selecting the application' "HELP" tab.
- 3. Clear all DTCs that may have been set in any module due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.

Reimbursable within the provisions of the warranty.

NOTE: The expected completion time for the flash download portion of this procedure is approximately 3 minutes. Actual flash download times may be affected by vehicle connection and network capabilities.

FAILURE CODE:

The dealer must choose which failure code to use depending on if this is a Rapid Response Transmittal (RRT) or Service Bulletin.

- The "RF" failure code is required for essential module flash/reprogramming and can only be used after confirmation that the VIN is included on the RRT.
- The failure code "RF" (Required Flash) can no longer be used on Service Bulletin flashes. **The** "**RF**" failure code must be used on an **RRT**.
- If the customer's concern matches the SYMPTOM/CONDITION identified in the Service Bulletin, failure code CC is to be used. When utilizing this failure code, the 3C's must be supplied.
