Incorrectly manufactured front hoods or doors have been have been installed on the affected vehicles (VINs) noted below.

- The front hoods do not have a circumferential PVC seal
- The doors do not have a part of the PVC seal and the relining adhesive applied

This could lead to internal corrosion.

CAUSE

Poor sealing of the hood and doors.

CORRECTION

Replace the affected hood or door as applicable.

PROCEDURE

Replace the affected hood or door based on the table below:

- Repair Instructions hood: 41 61 001 Replacing the hood
- Repair Instructions front door: 41 51 101 Replace the front left or right door
