Mailing Information:	In conjunction with the Ohio DMV, Volkswagen will be sending Takata airbag recall reminder notices to approximately 9,000 Volkswagen owners in the State of Ohio on February 10, 2020. Notes:	<div style="border: 2px solid red; padding: 2px;">IMPORTANT REMINDER: VEHICLES AFFECTED BY SAFETY & COMPLIANCE RECALLS</div> <u>New Vehicles in Dealer Inventory:</u> It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety. <u>Pre-Owned Vehicles in Dealer Inventory:</u> Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

URGENT AIRBAG SAFETY RECALL: IMMEDIATE ACTION REQUIRED!

The Ohio Bureau of Motor Vehicles (BMV) is contacting you personally because your vehicle has a recalled airbag that could **kill or seriously injure you and your passengers** if it deploys.

The BMV has received information from Volkswagen that the vehicle currently registered in your name with the Vehicle Identification Number [VIN] has been recalled. **If the airbag deploys, in some cases the airbag may explode** and spray sharp metal fragments or shrapnel toward you and your passengers.

According to records from Volkswagen, your vehicle has not been repaired yet. The potentially lifesaving repair is **FREE** and parts are available now. Please **immediately call a Volkswagen dealer** for more information or to schedule a **FREE** repair.

IF YOU NO LONGER OWN THIS VEHICLE: DISREGARD THIS LETTER

What should you do?

- **Immediately** contact a local Volkswagen dealer to schedule a **FREE** repair.

- *If you think you have already taken action on this recall, visit www.NHTSA.gov/recalls or www.airbagrecall.com and enter your vehicle's VIN to verify and ensure that no other recalls have been issued for your vehicle.*



ENTER YOUR VIN

Volkswagen is one of 19 vehicle manufacturers affected by this recall. The National Highway Traffic Safety Administration reports other auto manufacturers have 16 confirmed deaths in the United States and hundreds of alleged injuries resulting from this defect.

Please encourage your family and friends to check for vehicle safety recalls using their VIN at www.NHTSA.gov/recalls or www.airbagrecall.com. You and your family's safety on Ohio's roadways is our top priority.

Please act NOW to protect yourself and your passengers.

If you believe that Volkswagen or your Volkswagen dealer is unable to remedy the defect without charge within a reasonable time, you may submit a complaint to the Administrator, National Highway Traffic Safety Administration, 1200 New Jersey Avenue S.E., Washington, DC 20590, or you may call the toll-free Vehicle Safety Hot Line at 1-888-327-4236 (TTY: 1-800-424-9153), or go to NHTSA.gov.

This notice is being provided and paid for by Volkswagen, in cooperation with the Ohio Bureau of Motor Vehicles. Taxpayer dollars were not used. Due to the serious nature of this recall, the Ohio Bureau of Motor Vehicles is providing limited assistance with these notices to individuals who may be impacted by this recall. The manufacturer is fully responsible for this recall, notification of the recall, and any repairs. This notification does not create a duty upon the State of Ohio and the Ohio Bureau of Motor Vehicles to provide notice nor any repair requirement regarding this recall, or any other recalls or safety-related information.
