

#### **INTRODUCTION:**

This bulletin describes two operational concerns and the repair method for addressing them on the Harman Gen 3.1 Display Audio (Mid) and Navigation -equipped (High) head units. Base model head units are not affected. The conditions are:

- Unable to use the Map Over The Air (MOTA) update feature via smartphone
- After selecting Manual from the Clock Adjustment screen shown below, the user is unable to adjust the clock time display manually.



To restore the functionality of these features, the head unit must be replaced with the applicable exchange audio head unit as reprogramming cannot correct these concerns.
