• Remove and replace the catalytic converter with part 3QF254500MX, or part 3QF253059PX, before proceeding to the ECM software update below. Refer to repair manual group 26 Exhaust System in Elsa.

### **Update-Programming Procedure:**



<u>Critical Warning</u>: The Midtronics battery charger <u>must</u> be connected to the vehicle battery for the duration of the programming, to ensure the battery state of charge remains above 12.5 volts during the update process. If the battery drops below 12.5 volts, the programming could fail which may result in damage to the control module. Control modules damaged by inadequate voltage will not be covered under the warranty policy. The technician should verify the vehicle voltage prior to starting the update process, and should monitor the voltage for the duration of the update.

VAS tools must only be used with their power adapters plugged in. Under no circumstances should they be used on battery power alone during the programming procedure.

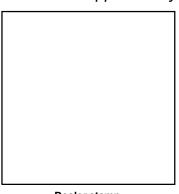
