When a vehicle arrives at the Service Department, access Hyundai Motor America's "Warranty Vehicle Information" screen via WEBDCS to identify open Campaigns.

Description:

This bulletin provides instructions related to an Electronic Control Module (ECM) software update to revise the fuel injection control logic. The update is for the applicable model listed below with SULEV emissions certification only.

A Campaign Sticker must be applied to all vehicles and an Emission Recall Proof of correction card completed in certain States as mentioned below in Parts Information Table. Please see page-4.

GDS Vehicle Battery Voltage Warning:

If voltage is below 12 volts as per the below GDS warning, then select **Back** and run the engine at least 20 minutes to ensure an adequate battery state of charge for reliable update results. Turn ignition back on, and then retry the ECU update again.

Campaign Sticker:

Fill in the information on the 00305-SC959 Campaign Sticker and apply onto the hood in the area below the Emission Label as shown.

Be sure to clean the mounting surface to ensure proper label adhesion.



Vehicle Emission Recall Proof of Correction Card:

The below is only required for vehicles registered in California, Connecticut, Delaware, Maine, Maryland, Massachusetts, New Jersey, New York, Oregon, Pennsylvania, Rhode Island, Vermont and Washington:

A Vehicle Emission Recall - Proof of Correction card must be filled out for all vehicles registered in California, Connecticut, Delaware, Maine, Maryland, Massachusetts, New Jersey, New York, Oregon, Pennsylvania, Rhode Island, Vermont and Washington. Residents of these states, who own an affected vehicle, will be required to possess a Vehicle Emission Recall - Proof of Correction card as evidence of voluntary service campaign completion when they apply for vehicle registration renewal.

WHAT TO DO WITH THE CARD:

The Vehicle Emission Recall - Proof of Correction card <u>must</u> be completed by the Dealership's Service Manager using a permanent ink pen. A fine point pen is recommended. When filling in the information, copy the information directly from the vehicle, <u>not</u> from the repair order. <u>ALL</u> <u>INFORMATION MUST BE PRINTED AND NEAT.</u>

The completely filled out Vehicle Emission Recall - Proof of Correction card should be given to the owner of the vehicle upon completion of the Campaign.
