VOLUNTARY EMISSIONS RECALL CAMPAIGN 2018 ALTIMA AND ROGUE; EXHAUST MANIFOLD AND THREE WAY CATALYST ASSEMBLY

INTRODUCTION

Nissan is conducting this voluntary emissions recall campaign on certain specific model year 2018 Altima and Rogue vehicles. The exhaust manifold and three way catalyst assembly and two exhaust sensors will be replaced. This service will be performed at no charge to the customer for parts or labor.

IDENTIFICATION NUMBER

Nissan has assigned identification number PC717 to this campaign. This number must appear on all communication and documentation of any nature dealing with this campaign.

DEALER RESPONSIBILITY


It is the dealer's responsibility to check Service COMM or Dealer Business Systems (DBS) National Service History for the campaign status on each vehicle falling within the range of this voluntary emissions recall which for any reason enters the service department. This includes vehicles purchased from private parties or presented by transient (tourist) owners and vehicles in a dealer's inventory. Federal law requires that new vehicles in dealer inventory which are the subject of an emissions recall must be corrected prior to sale. Failure to do so can result in civil penalties. While federal law applies only to new vehicles, Nissan strongly encourages dealers to correct any used vehicles in their inventory before they are retailed.

Nissan Bulletins are intended for use by qualified technicians, not 'do-it-yourselfers'. Qualified technicians are properly trained individuals who have the equipment, tools, safety instruction, and know-how to do a job properly and safely. **NOTE:** If you believe that a described condition may apply to a particular vehicle, DO NOT assume that it does. See your Nissan dealer to determine if this applies to your vehicle.

IMPORTANT

Attention California Dealers

An Emission Recall Campaign Completion (ERCC) label must be filled out by the technician performing the repair, and then attached to the underside of the vehicle hood. A sample of the label is shown below.



California law prohibits owners from renewing their California registration if emissions related recall work has not been performed. California dealers are now required to issue a proof of correction certificate to vehicle owners upon completion of emissions related recall work. Please fill out one of the campaign completion forms for each owner that has this campaign performed. Instruct owners to keep this certificate unless they are requested to mail it to the DMV. A sample of the form is shown in Figure 2 below.

- When either item (form or label) is ordered, you will automatically receive the other item as well.

SERVICE PROCEDURE

IMPORTANT: Follow all cautions, warnings, and notes in the Electronic Service Manual (ESM) when working on or around the engine.

- 1. Replace the following:
 - Exhaust manifold and three-way catalyst assembly
 - Air fuel ratio (A/F) sensor 1
 - Heated (rear) oxygen sensor 2
 - Altima: For exhaust manifold and three-way catalyst replacement, go to the ESM, section ENGINE - ENGINE MECHANICAL - QR25DE - REMOVAL AND INSTALLATION - EXHAUST MANIFOLD AND THREE WAY CATALYST.
 - Rogue: For exhaust manifold and three-way catalyst replacement, go to the ESM, section ENGINE - ENGINE MECHANICAL - REMOVAL AND INSTALLATION - EXHAUST MANIFOLD AND THREE WAY CATALYST.





Rogue - Exhaust Manifold and Three Way Catalyst




