Please see below for addition information being added to our User Manuals in regards to Decontamination Product

Please follow CDC Guidelines on how to decontaminate the module or/and chassis cab. When decontamination of the module or/and chassis cab is required use caution and strictly follow the manufacturer's instructions. Beware that certain decontamination products can have adverse effects to different components within the module or/and chassis cab which may not be covered by the warranty of this unit. Always follow the manufacturer's safety recommendations while working with decontamination products including:

- Use only EPA registered products
- Avoid breathing mist or vapors
- Wear Gloves (resistant to chemical products [butyl rubber, nitrile and neoprene, polyethylene, polyvinyl chloride])
- Wear protective clothing
- Wear eye protection (face shield or safety glasses)
- Wear Respiratory protective equipment (air respirator or SCBA)

As you probably already know, our employees are committed to working through the crisis, and there is a feeling of doing our part by continuing to make ambulances. FCA (RAM) Chassis Production Update - New

FCA (RAM) intends to progressively restart its U.S. and Canadian manufacturing facilities beginning Monday, May 4. We are also hearing that Ford/GM are also planning on starting back up production on May 4th as well, but so far that is unofficial.

Freightliner Chassis Production Update - New

Daimler Trucks North America truck plants are going to be closed an additional week. They are now schedule to reopen on 4/20.

Ohio Stay at Home Order Extended Through May 1

Governor DeWine's issued a new order on Thursday, April 2, 2020. For the first time in Ohio, the Governor is directing that, generally, travelers entering the state with the intention to stay should self-quarantine for 14 days. We feel the intent of this order prohibits out of state inspection at Horton. We have fewer and fewer of those on our calendar, so this has become less of an issues, but, ***effective immediately***, Horton is going to comply with our interpretation of the Governor's order by **prohibiting** all out of state inspection at Horton. **This applies to both dealers and customers.**

Ford Production Update

As you are aware, OEM information coming out to us is very fluid right now. The last information we have received from Ford is that they have decided to further postpone start up due to producing an FDA-Cleared ventilator at its Rawsonville Components Plant during the COVID-19 pandemic. Once we here additional information, we will share it.

Navistar/International Update

Production has been suspended. No start up date. Once we here additional information, we will share it.

Prior to Delivery of Ambulance

We are wiping down all chassis cab interior with alcohol prior to putting the unit outside for delivery. This wipe down will occur as the last step. We will hang a tag with the date, time, and initials of the team member performing the action on the rear view mirror.

Horton Standard Air Filter in HVAC System

Horton recommends replacing Module Air Filters every 6 months or 10,000 miles. Most filter take less than 10 minutes to exchange. Periodic visual inspection should be the primary consideration of when filters require replacement, as ambulance use and climate will dictate the effective life of air filter. Other indicators that a filter might need to be replaced could be reduced air flow, reduced power from the unit, and/or increase dust/allergens in the module. Ambulance operating in high pollutant areas may require a severe maintenance interval. Under these circumstances, replacement should be evaluated on a case by case basis.
