#### SUBJECT:

Vehicle Pulls or Leads

### **OVERVIEW:**

This bulletin involves properly correcting a lead/pull condition due to inaccurate alignment settings from the plant.

### **MODELS:**

2020 (DT) RAM 1500 Pickup

NOTE: This bulletin applies to vehicles within the following markets/countries: North America.

NOTE: This bulletin applies to vehicles built on or after January 24, 2020 (MDH 0124XX) and on or before March 06, 2020 (MDH 0306XX).

#### SYMPTOM/CONDITION:

The customer may describe the vehicle pulls or leads either left or right.

### **DIAGNOSIS:**

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. **This RRT only applies** to vehicles on the **RRT VIN list**.

- 1. Is the vehicle an unsold vehicle?
  - YES>>> Proceed to Step 1 of the Repair Procedure.
  - NO>>> Proceed to Step 2 of the Inspection Procedure.
- 2. Customer owned (sold) vehicles (only), test drive the vehicle to confirm a pull or lead.
- 3. Does the vehicle pull to the left or right?
  - YES>>> Proceed to Step 1 of the Repair Procedure.
  - NO>>> This Bulletin has been completed. Use inspect LOP (02-00-01-9R) to close the active RRT.
