Overview

Under certain regional environmental conditions, e.g. dust and humidity, there is a possibility that particles of dirt can get into the tank leakage diagnosis module.

This can cause an over-sensitive tank leakage diagnosis and the Check Engine light may be activated.

To prevent this, the tank leakage diagnosis module and the air filter for the carbon canister must be replaced. Please arrange for this measure to be carried out on the affected vehicles the next time the vehicles come into the workshop.
