***** Campaign Summary *****

Nissan is conducting a Voluntary Emissions Recall Campaign on **12,382** MY2018 NV200 vehicles identified in Service Comm to reprogram the Engine Control Module (ECM) with countermeasure software.

Nissan has determined that the subject vehicles may be equipped with an improperly calibrated Engine Control Module (ECM). If not repaired, the On-Board Diagnostic (OBD) system may not properly detect a catalyst issue that could result in exhaust gas emissions exceeding standards.

***** What Dealers Should Do*****

1. Verify campaign applicability using Service Comm or DBS National Service History – Open Campaign I.D. **PM947**.
2. Dealers should use **NTB20-039** to correct any vehicles subject to this campaign.
3. Once repaired, dealers should submit the claim, using the claims coding provided, and release the vehicle.

****** Dealer Responsibility ******

It is the dealer's responsibility to check Service Comm or DBS National Service History Open Campaign using the appropriate Campaign I.D. for the campaign status on each vehicle falling within the range of this voluntary emissions recall campaign, which for any reason enters the service department. This includes vehicles purchased from private parties or presented by transient (tourist) owners and vehicles in dealer inventory. If a VIN subject to this recall campaign was part of a dealer trade, the letter associated with that VIN should be forwarded to the appropriate dealer for service completion.

Frequently Asked Questions (FAQ):

Q. Is this a Stop Sale?

A. Yes.

Q. Is my vehicle safe to drive?

A. Yes.

Q. What is the reason for this emission recall?

A. Nissan has determined that the subject vehicles may be equipped with an improperly calibrated Engine Control Module (ECM).

Q. What is the possible effect of the condition?

A. If not repaired, the On-board Diagnostic (OBD) system may not properly detect a catalyst issue that could result in exhaust gas emissions exceeding standards.

Q. What will be the corrective action?

A. Dealers will reprogram the Engine Control Module (ECM) with countermeasure software.

Q. How long will the corrective action take?

A. The remedy should take approximately one (1) hour to complete. The dealer may require the vehicle for a longer period of time based upon the dealer's work schedule.

Q. When will vehicle owners be notified?

A. Nissan will begin sending notifications to owners of all potentially affected vehicles in **June 2020** via U.S. Mail.

Q. Is there anything owners can do to mitigate this condition?

A. No.

Q. Is there any charge for this repair?

A. No, the remedy will be performed for the customer free of charge for parts and labor.

Q. Will a rental vehicle be provided while the dealer is servicing the vehicle?

A. Please consult your dealer for alternate transportation availability while your vehicle is being serviced. **If the reprogramming cannot be performed successfully** and an engine control module needs to be ordered, rental is available upon customer request.

Q. Will I have to take my vehicle back to the selling dealer to have the service performed?

A. No, any authorized Nissan dealer is able to perform the recall campaign.

Q. I have lost confidence in the vehicle. Will Nissan replace or repurchase the vehicle?

A. The remedy will fully correct this condition. As the condition will be corrected, there is no basis for repurchasing or replacing your vehicle.

Q. What model year vehicles are involved?

A. Certain MY2018 NV200 (M20) vehicles manufactured in Cuernavaca, Mexico between October 3, 2017 and August 8, 2018 are affected.
