	<ul> <li>The parking lights and LED strip are On</li> </ul>
	The center-stack and radio will be operational
	<ul> <li>When the engine is stopped and the HSLAN bus goes to sleep, fault condition is cleared.</li> </ul>
	Some customers may also comment that the vehicle begins to crank, stops cranking and then has a successful start.
	<b>Note:</b> U0100 alone is not a good indication of this issue. A better indication of the condition are the symptoms listed above.
	If vehicle is left in this condition for an extended period, some technicians may find U0100 (Lost Communication With Engine Control Module) set.
	Some technicians may also find when the engine is stopped and the HSLAN bus goes to sleep, the fault condition is cleared.
Cause	This condition may be caused by a software anomaly.
Correction	If you encounter a vehicle with any of the above conditions, reprogram the Engine Control Module (ECM) with the latest available software.

#### **Service Procedure**

**Caution:** Before downloading the update files, be sure the computer is connected to the internet through a network cable (hardwired). DO NOT DOWNLOAD or install the files wirelessly. If there is an interruption during programming, programming failure or control module damage may occur.

**Important:** Carefully read and follow the instructions below.

- Ensure the programming tool is equipped with the latest software and is securely connected to the data link connector. If there is an interruption during programming, programming failure or control module damage may occur.
- Stable battery voltage is critical during programming. Any fluctuation, spiking, over voltage or loss of voltage will interrupt programming. Install a GM Authorized Programming Support Tool to maintain system voltage. Refer to www.gmdesolutions.com for further information. If not available, connect a fully charged 12 V jumper or booster pack disconnected from the AC voltage supply. DO NOT connect a battery charger.
- Turn OFF or disable systems that may put a load on the vehicles battery such as; interior lights, exterior lights (including daytime running lights), HVAC, radio, etc.
- Clear DTCs after programming is complete. Clearing powertrain DTCs will set the Inspection/ Maintenance (I/M) system status indicators to NO.



System dialogue box of the SPS Summary screen. No further action is required. Refer to the Warranty section of the bulletin.

<ul> <li>When more than one Warranty Claim Code is generated for a programming event, it is required to document all Warranty Claim Codes in the "Correction" field on the job card. Dealers must also enter one of the codes in the "SPS Warranty Claim."</li> </ul>			

Claim Codes in the "Correction" field on the job card. Dealers must also enter one of the codes in the "SPS Warranty Claim Code" field of the transaction, otherwise the transaction will reject. It is best practice to enter the FINAL code provided by SPS.

#### Warranty Claim Code Information Retrieval

If the SPS Warranty Claim Code was not recorded on the Job Card, the code can be retrieved in the SPS system as follows:

- 1. Open TIS on the computer used to program the vehicle.
- 2. Select and start SPS.
- 3. Select Settings.
- 4. Select the Warranty Claim Code tab.

The VIN, Warranty Claim Code and Date/Time will be listed on a roster of recent programming events. If the code is retrievable, dealers should resubmit the transaction making sure to include the code in the SPS Warranty Claim Code field.
