WLE3 Workshop campaign - Replacing 12V vehicle electrical system battery

Version 1

Overview

Due to a manufacturing error, there is a possibility that the internal current sensor for the 12-volt vehicle electrical system battery does not meet the required specifications on the affected vehicles. As a result, the charge state will be calculated incorrectly and the 12-volt vehicle electrical system battery will then be completely discharged when the vehicle is parked up for extended periods without an external power supply.

To prevent this from happening, the 12-volt vehicle electrical system battery (lithium-ion battery) must be replaced.

Please arrange for this measure to be carried out on the affected vehicles during the next workshop visit or before handing the vehicles over to customers.
