AFFECTED VEHICLES

This Service Action involves 1 (one) G20 3 Series and 1 (one) G30 5 Series produced April 2019 to October 2019.

Vehicles which require this Service Action to be completed will show it as "Open" when checked either in AIR, the "Service Menu" of DCSnet (Dealer Communication System) or with the Key Reader.

SITUATION

A software error in the telematics control unit can result in an interruption in communication between the vehicle and the back end (BMW server).

CAUSE

Software error in the Advanced Telematics Module (ATM).

CORRECTION

Program the vehicle.

PROCEDURE

- 1. Determine the vehicle's current I-level by either using AIR or ISPA NEXT application.
- 2. Is the current vehicle integration level:

G30	S15A-19-11-570 or higher

NO: Proceed to Step 3

YES: Further diagnosis with ISTA is needed

3. Program the vehicle using ISTA 4.22.1x or higher (released March 2020).

Note that ISTA will automatically reprogram and code all programmable control modules that do not have the latest software.

Always connect a BMW-approved battery charger/power supply (SI B04 23 10).

Parts exchange will not provide a solution.

WARRANTY INFORMATION
