IF YOU CONFIRM

The engine will not crank and will not start, but the battery test result is OK,


OR

One of these DTCs are stored:

- C1142 (PRESS SENSOR)
- C1A04 (ABS/TCS/VDC SYSTEM)
- C1A26 (ECD MODE MALFUNCTION)

AND

The color of the stop lamp switch is solid black, as shown in Figure 1.



ACTION


Replace the stop lamp switch.

IMPORTANT: The purpose of ACTION (above) is to give you a quick idea of the work you will be performing. You MUST closely follow the entire SERVICE PROCEDURE as it contains information that is essential to successfully completing this repair.

SERVICE PROCEDURE

- 1. Replace and adjust the stop lamp switch.
 - For stop lamp switch replacement and adjustment, refer to the Electronic Service Manual (ESM), section BRAKES > BRAKE SYSTEM > PERIODIC MAINTENANCE > BRAKE PEDAL.





NOTE: The updated stop lamp switch will have a black body with a green connector end.

CLAIMS INFORMATION

Submit a Primary Part (PP) type line claim using the following claims coding:

DESCRIPTION	PFP	OP CODE	SYM	DIA	FRT
RPL STOP LAMP SWITCH	(1)	PF26AA	ZE	32	(2)

(1) Reference the electronic parts catalog and use the Stop Lamp Switch Assy (25320-****) as the Primary Failed Part (PFP).

(2) Reference the current Nissan Warranty Flat Rate Manual and use the indicated Flat Rate Time (FRT).

NOTE: The FRT allows adequate time to access DTC codes. No other diagnostic procedures subsequently required. Do Not claim any other diagnostic operation codes with this claim.
