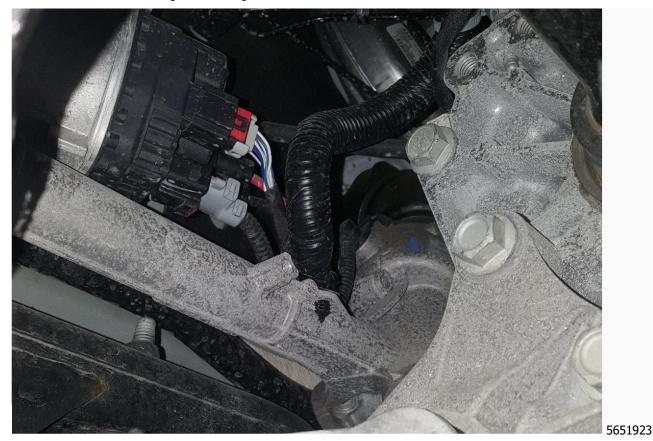

Service Procedure

1. Lift the vehicle. Refer to Lifting and Jacking the Vehicle in SI.



2. Inspect the engine harness branch where it clips into the Power Steering rack as shown.

- If the engine harness is clipped into the rack, no further action is required.
- If the engine harness is not clipped into the rack, secure the harness to the rack using the push pin fastener attached to the harness as shown.
- 3. Lower the vehicle. Refer to *Lifting and Jacking the Vehicle* in SI.

Dealer Responsibility

Whenever a vehicle subject to this service update enters your vehicle inventory or is in your facility for service in the future, and the vehicle is still covered under the New Vehicle Limited Warranty, you must take the steps necessary to be sure the service update correction has been made before selling or releasing the vehicle.
