SUBJECT:

Engine Ticking Noise

OVERVIEW:

This bulletin involves replacing the bank 1 exhaust cam phaser, phaser actuator and Oil Control Valve (OCV).

MODELS:

2020 (RU)

Chrysler Pacifica

NOTE: This bulletin applies to vehicles within the following markets/countries: North America.

NOTE: This bulletin applies to vehicles built on or after August 18, 2020 (MDH 0818XX) and built on or before August 20, 2020 (MDH 0820XX) equipped with a 3.6L V6 24V VVT Engine (Sales Code ERC).

SYMPTOM/CONDITION:

Customers may experience a Malfunction Indicator Lamp (MIL) illumination. Upon further investigation, a technician may find one or more of the following Diagnostic Trouble Codes (DTCs) have been set:

- P000A Bank 1 Camshaft 1 Position Slow Response.
- P0365 Camshaft Position Sensor Circuit Bank 1 Sensor 2.
- P0300 Multiple Cylinder Misfire.
- P105C Intake Valve Stuck In Low Lift Position.

Customers may also experience one or more of the following:

- Engine ticking noise.
- Reduced level of engine performance.

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a VIN is listed in VIP or your RRT VIN list, perform the Inspection Procedure. **This RRT only applies to vehicles on the RRT VIN list.**
