******* Campaign Summary*******

Nissan is providing owners of approximately **11,358** MY2020 Nissan Titan (A61) vehicles with a supplemental Owner's Manual addendum booklet. Nissan discovered the Owner's Manual is missing the standard description of seat belt pretensioner(s) applied for rear outboard seating positions. Customers will be asked to place the supplemental Owner's Manual addendum booklet inside the vehicle's glove box.

******* What Dealers Should Do *******

1. Verify if new vehicles in their inventory are affected by this Voluntary Service Campaign using Service Comm or DBS National Service History – Open Campaigns I.D. **PC755.**
 - **New vehicles in dealer inventory can also be identified using DBS (Sales-> Vehicle Inventory, and filter by Open Campaign).**
 - Refer to NPSB 15-460 for additional information
 - SERVICE COMM will only be active for vehicles in **new vehicle dealer inventory.**
2. If a dealer receives a supplemental Owner's Manual addendum booklet for a vehicle they have retailed, currently have in their new vehicle or pre-owned inventory, or a Nissan Rental Car (NRC), the dealer should either forward the owner's manual addendum to the current owner or add the addendum to the glove box of any affected vehicle they currently control.
3. Customers receiving this addendum booklet have been advised to insert this booklet into their glove box.

A. The Owner's Manual is missing the standard description of seat belt pretensioner(s) applied for rear outboard seating positions.

Q. What will be the corrective action?

A. Nissan is providing affected owners with a supplemental addendum booklet for their 2020 Nissan Titan Owner's Manual, which describes the seat belt pretensioner(s) applied for rear outboard seating positions. Customers will be asked to place the supplemental Owner's Manual addendum booklet inside the vehicle's glove box.

Q. When will vehicle owners be notified?

A. Rear Seat Belt Owner's Manual addendum booklet and owner's letter shipments have been delayed. Nissan will mail a supplemental Owner's Manual addendum booklet and owner's letter to all affected customers in **November** 2020.

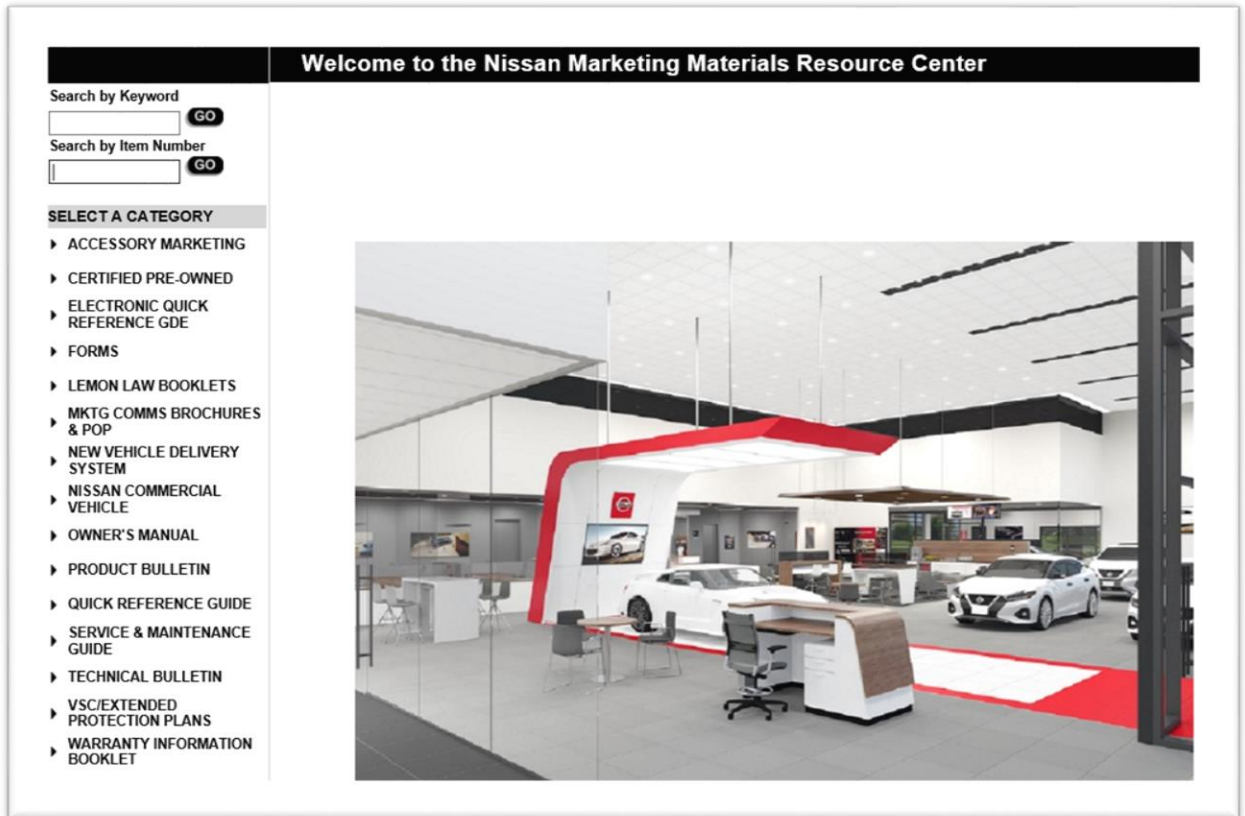
Q. Will I have to take my vehicle back to the selling dealer or contact a dealer to obtain a new owner's manual?

A. No, supplemental owner's manual addendum booklets will be mailed directly to affected owners.

Q. I am a dealer, how do I obtain a copy for a lost or missing addendum?

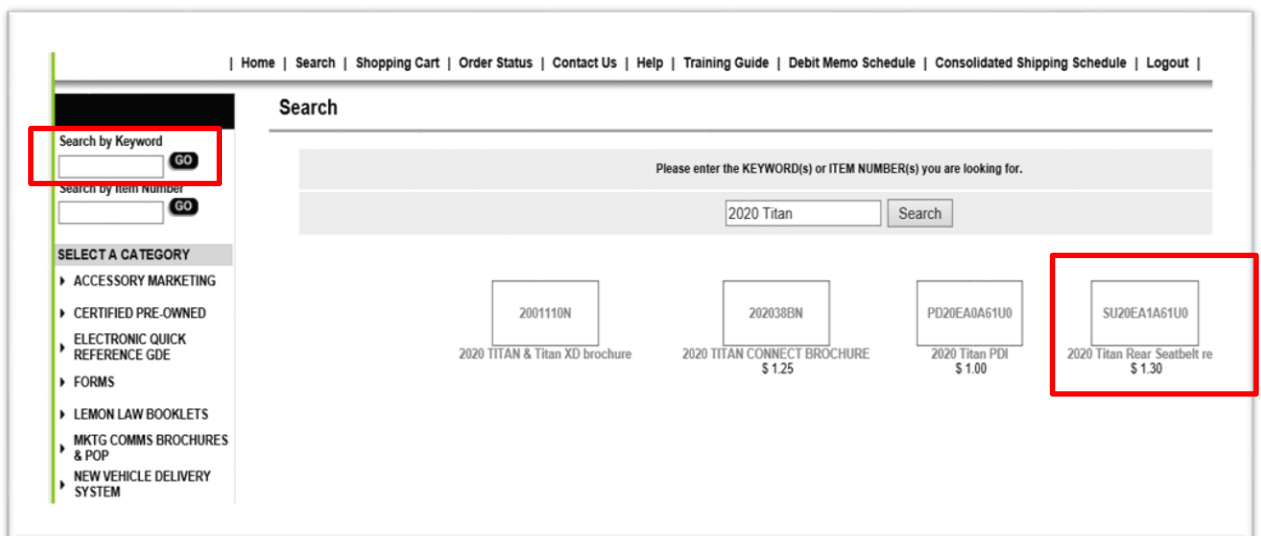
A. Additional addendums may be obtained as needed via the Dealer's Material Ordering site located under Dealer Operations in NNAnet.

- Login to NNAnet.com and select the "My Links" tab
- Under Dealer Operations, select "Dealer Materials Ordering" – this will take you to the reorder site.



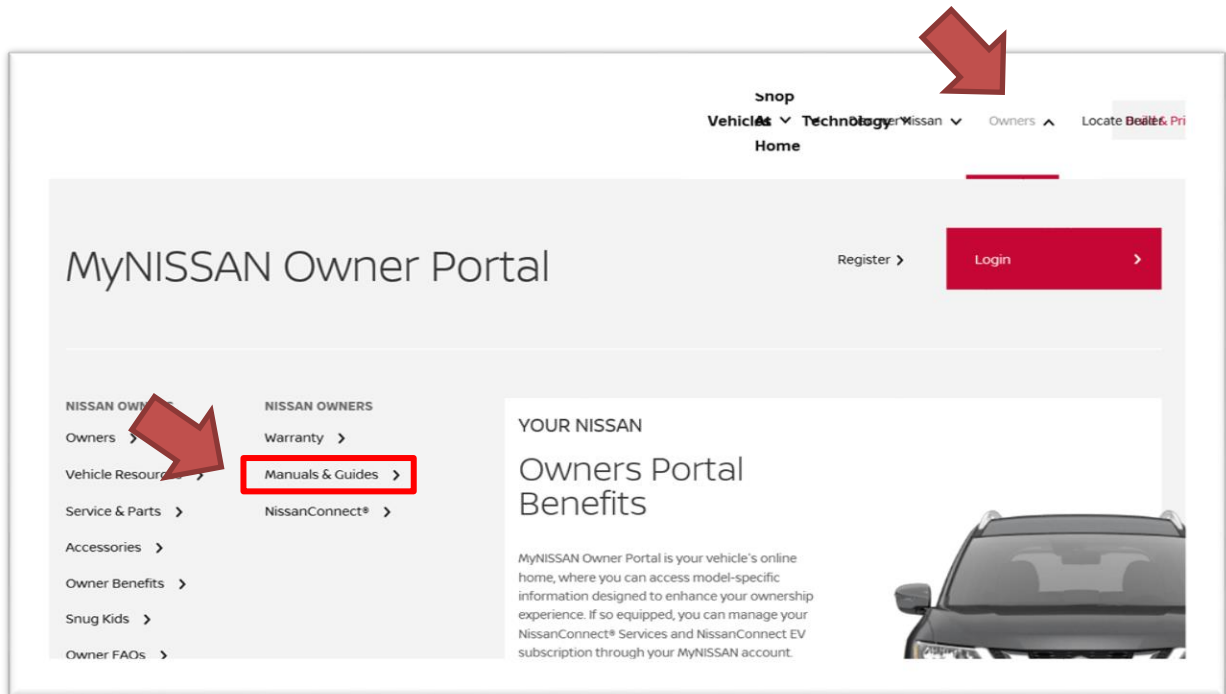
To locate the addendum, enter '2020 Titan' in the Search by Keyword field at the top, and select 'GO'.

Then select 'SU20EA1A61U0' to add it to your cart.

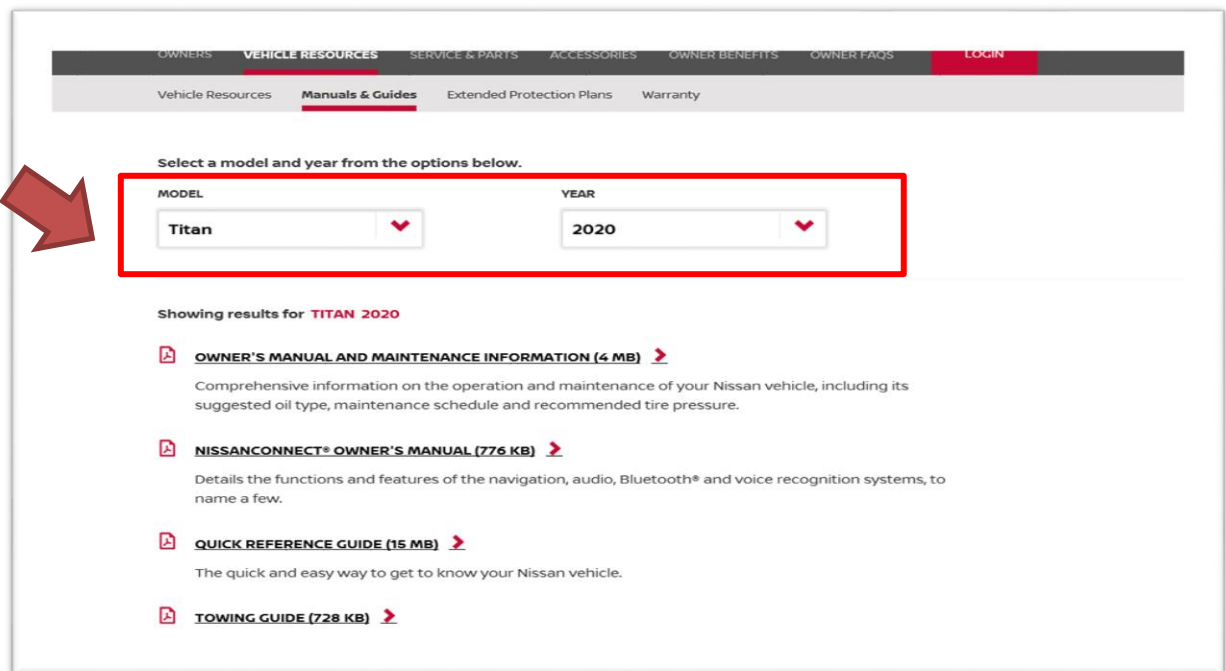


Q. I am a customer, how do I obtain a copy of a lost or missing addendum?
