TECHNICAL SERVICE BULLETIN

SERVICE ACTION: ENGINE LOT INSPECTION AND SUB-ENGINE & TURBOCHARGER REPLACEMENT (SA458)

This bulletin provides information to inspect the engine Lot Number and if necessary, replace the sub-engine assembly and turbocharger on some 2021MY Stinger (CK) vehicles equipped with Theta 2.0L T-GDI engine, produced from October 14, 2020 through October 17, 2020, which may exhibit reduced engine performance with loud noise and/or MIL 'ON' with DTC P029900 due to poor oil flow to the turbo charger. Before conducting the procedure, verify that the vehicle is included in the list of affected VINs (94 VINs). Please perform this repair on all applicable vehicles in your dealer inventory prior to sale.

DTC Description: P029900 - Turbo boost below target value



* NOTICE

A Service Action is a repair program without customer notification that is performed during the warranty period. Any dealer requesting to perform this repair outside the warranty period will require DPSM approval.

SERVICE ACTION: ENGINE LOT INSPECTION AND SUB-ENGINE & TURBOCHARGER REPLACEMENT (SA458)

Engine Lot Inspection:

- 1. Open the hood and remove the engine cover.
- 2a. Remove the two (2) coolant line bracket retaining bolts.


Torque specification for bolt(s): 7.2 – 8.7 lb.ft (9.8 – 11.8 N.m, 1.0 – 1.2 kgf.m)

2b. Lift up the coolant line in order to view the engine lot number.

<u>Note</u>: It may be necessary to use a cell phone camera to clearly view/read the stamped lot number. The engine shown to the right has been removed and for reference use only.

- 3a. Check the Lot Number on the center of the cylinder block located behind the alternator.
- 3b. If the Lot Number falls within the engine production date range shown, then follow the 'Sub-Engine and Turbocharger Replacement Procedure' outlined on page 3.
- 3c. If the Lot Number does not fall within the engine production date range shown, no further action is required.
- 4. Reinstall the two (2) coolant line bracket retaining bolts from step 2a.

Sub-Engine and Turbocharger Replacement Procedure:

Replace the Sub-Engine assembly by referring to the "Engine Mechanical System → Engine and Transmission Assembly → Engine and Transmission Assembly → Repair procedures" chapter in the applicable Shop Manual on KGIS.

Replace the turbocharger by referring to the "Engine Mechanical System \rightarrow Intake and Exhaust System \rightarrow Turbocharger & Exhaust Manifold \rightarrow Repair procedures" chapter in the applicable Shop Manual on KGIS.

<u>Note</u>: Be sure to install the new replacement turbocharger <u>prior</u> to installing the engine into to the vehicle.

A CAUTION

Removing/tightening the fuel lines is very important, especially when tightening GDI fuel lines. Please use the proper tightening torque by referring to the "Engine Control/Fuel System \rightarrow Specifications \rightarrow Tightening Torque" chapter in the applicable Shop Manual on KGIS.

- 2a. Confirm normal vehicle operation after replacement of the sub-engine and turbocharger.
- 2b. Confirm no oil or fuel leaks are present.
