#### Service Procedure

Inspect the rear bumper fascia trailer hitch cover:

- If the rear bumper fascia trailer hitch access hole cover does not sit flush with the fascia or is loose, replace the rear bumper fascia trailer hitch access hole cover. Refer to Rear Bumper Fascia Trailer Hitch Access Hole Cover in SI.
- 2. If the rear bumper fascia trailer hitch access hole cover sits flush and is secure, no further action required.

#### **Dealer Responsibility**
