SUBJECT:

Heating, Ventilation and Air Conditioning (HVAC) Controls Inoperative

OVERVIEW:

This bulletin involves replacing the HVAC module.

SYMPTOM/CONDITION:

• Customers may experience not being able to change the HVAC modes, both on the radios display or HVAC controls.

DIAGNOSIS:

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If DTCs or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. This RRT only applies to vehicles on the RRT VIN list.

REPAIR PROCEDURE:

- Replace the HVAC module. Refer to the detailed procedures available in DealerCONNECT > Service Library> under: 08 - Electrical / 8E - Electronic Control Modules / Module, HVAC / Removal and Installation.
- 2. Clear all DTCs that may have been set in any module due to reprogramming. The wiTECH application will automatically present all DTCs after the flash and allow them to be cleared.
