**Subject** Detroit New Service Replacement Engine SRT Update

#### Overview

While validating Standard Repair Times (SRTs) for Detroit's new Gen 5 engine series, DTNA discovered an error in a pre-Gen 5 SRT for the New Service Replacement Engine Program. As a result, DTNA re-studied the SRT and concluded that time for removing/re-installing multiple components (e.g., exhaust manifold/turbo, engine sensor harness, rocker arm assemblies, etc.) should not be included. Consequently, DTNA is adjusting times for some chassis/engine service models; updated times will be applied to repair orders opened on or after January 17, 2021.

# Updated Labor Operation

The table below identifies the impacted SRT, chassis service models, engine series, and labor times. Please note the updates only affect this SRT; Standard Diagnostic Times (SDTs) and other SRTs related to this repair are not changing. Appropriate SDTs/SRTs should be claimed, as needed, for repairs associated with installing a new service replacement engine. Claiming the applicable SRTs/SDTs will ensure full technician labor can be recovered. For example, rod/main bearing failures may require a technician to use the bearing failure guide to determine root cause; if so, the corresponding SDT is Lower End Bearing Failure Analysis (101-035EE).
