	1. Transmission fluid flushing should only be performed when instructed by Workshop Manual or any other Mazda publication.
Transmission flushes	2. Transmission fluid replacement is only recommended on B-Series Truck and Tribute and should be performed only at the mileage intervals specified in the owner's manual.
	<ol> <li>Transmission flushing is recommended if the customer accidentally adjusted the transmission level using an incompatible type of fluid.</li> </ol>
Transmission oil additives	<ol> <li>Transmission oil additives could (under certain conditions) lead to internal damage and void the warranty.</li> </ol>
Engine flushes	<ol> <li>Engine oil flushes are unnecessary.</li> <li>Contaminated oil from flushing machines may damage the engine and void the warranty.</li> </ol>
Engine oil additives	<ol> <li>These additives could (under certain conditions) lead to engine damage, prevent piston rings from sealing, and void the warranty.</li> </ol>
Engine cooling system flushing	<ol> <li>Mazda recommends coolant replacement starting at 100,000 miles of service on all models since 2008 (except B-Truck and Tribute). Prior to 2008, some vehicles have a replacement starting at 100,000 miles and 2 years on others, depending on the model.</li> <li>Flushing the coolant system is only recommended if the customer accidentally</li> </ol>

Nitrogen for tires	<ol> <li>Fuel injector malfunctions should only be repaired by replacement.</li> <li>Compressed air contains approximately 80 percent nitrogen.</li> <li>There is no practical value added from filling tires with nitrogen.</li> </ol>
Brake fluid flushes	<ol> <li>Brake fluid flushing should only be performed when instructed by Workshop Manual or any other Mazda publication.</li> <li>Contaminated fluid from flushing machines may damage the brake system and void the warranty.</li> </ol>
Power Steering fluid flushes	<ol> <li>Power Steering fluid flushing should only be performed when instructed by Workshop Manual or any other Mazda publication.</li> <li>Contaminated fluid from flushing machines may damage the power steering system and void the warranty.</li> </ol>
