APPLICABLE MODEL/VINS

2019-2021 Mazda3 4-door SD (Japan built) with VINS lower than JM1BP*****320356 (produced before November 3. 2020)

DESCRIPTION

Some customers may complain about water in the trunk compartment after a car wash or heavy rain. This may be caused by insufficient sealing performance of the trunk lid weatherstrip because the lip of the weatherstrip leans towards the inside of the trunk compartment (improper design). To correct this concern, the shape of the trunk lid weatherstrip has been modified.

Customers having this concern should have their vehicle repaired using the following repair procedure.

REPAIR PROCEDURE

- 1. Verify customer concern.
- 2. Replace the trunk lid weatherstrip with a modified one according to the instructions on MGSS (TRUNK LID WEATHERSTRIP INSTALLATION).
- 3. Verify repair.
