Issue: Some 2021 F-150 vehicles equipped with a 3.5L PowerBoost engine and built on or before 15-Feb-2021 may experience an illuminated malfunction indicator lamp (MIL) with diagnostic trouble codes (DTC) P2C23, P2601, P164C, and/or P060B stored in the powertrain control module (PCM). This may be due to various software parameters within the PCM. To correct the condition, follow the Service Procedure to reprogram the PCM.

Action: Follow the Service Procedure steps to correct the condition if the vehicle meets all of the following criteria:

- 2021 F-150
- 3.5L PowerBoost engine
- Built on or before 15-Feb-2021
- Exhibits an illuminated MIL with DTCs P2C23, P2601, P164C, and/or P060B stored in the PCM

Warranty Status: Eligible under provisions of New Vehicle Limited Warranty (NVLW)/Emissions Warranty/Service Part Warranty (SPW)/Special Service Part (SSP)/Extended Service Plan (ESP) coverage. Limits/policies/prior approvals are not altered by a TSB. NVLW/Emissions Warranty/SPW/SSP/ESP coverage limits are determined by the identified causal part and verified using the OASIS part coverage tool.

Service Procedure

1. Reprogram the PCM using the latest software level of the appropriate Ford diagnostic scan tool.
