APPLICABLE MODEL(S)/VINS

2019-2020 Mazda3 (Japan built) with VINS lower than JM1BP*****152092 (produced before September 10, 2019)

2019-2020 Mazda3 (Mexico built) with VINS lower than 3MZBP*****122329 (produced before September 27, 2019)

2020 CX-30 with VINS lower than 3MVDM*****101496 (produced before October 30, 2019)

DESCRIPTION

Some vehicles (equipped with the Electrical supply unit (ESU) BCKA-67-5Z0B) may exhibit that DTC B2002:49 [BODY CONTROL MODULE (BCM) - Electrical supply unit (ESU) internal malfunction (No warning/indicator light ON)] will not clear with the Mazda Modular Diagnostic System (M-MDS). This is caused by improper control software of the ESU. To eliminate this concern, the control software of the ESU has been modified.

NOTE: To clear DTC B2002:49, regardless of this TSB, disconnect the battery cable and wait for at least 5 seconds. Then connect the battery cable and wait for 150 seconds (2

minutes and 30 seconds). (Self-diagnosis on the ESU is performed right after the battery reset and requires 150 seconds maximum.)

Customers having this concern should have their vehicle repaired using the following repair procedure.

REPAIR PROCEDURE

1. Verify customer concern.

NOTE: If the customer is using the MyMazda App, explain to them that the malfunction information may be sent for the DTC detected during the repair before proceeding to the reprogramming.

Check the current software version of the ESU with the Mazda Modular Diagnostic System (M-MDS), using Mazda Diagnostic And Repair Software (MDARS).

- If current calibration file name in the ECU FILENAME screen is BEMD-66S07-B, proceed to step 3.
- If not, proceed to step 4.

3. Reprogram the ESU using the Mazda Diagnostic And Repair Software (MDARS), then go to step 4. Refer to MDARS ECU Reprogramming Procedure. **NOTE:**

- If current calibration file name in the ECU FILENAME screen is the same as shown in Calibration Files Information or with later suffix, reprogramming is not necessary.
- After reprogramming, pending DTC P2610:00 [PCM] will be stored without the Check Engine light ON. Start the engine and clear the DTC.
- After reprogramming, if DTC U2120:00 and/or U2500:82 are stored and the i-ACTIVSENSE warning light (amber) turns ON, refer to SA-043/20.

4. To clear DTC B2002:49, disconnect the battery cable and wait for at least 5 seconds. Then connect the battery cable and wait for 150 seconds (2 minutes and 30 seconds). (Self-diagnosis on the ESU is performed right after the battery reset and requires 150 seconds maximum.) **NOTE:** Even after the reprogramming, DTC B2002:49 will not clear without waiting for 150 seconds or longer after battery reset.

- If DTC B2002:49 has been cleared, proceed to next step.
- If DTC has not been cleared, replace the ESU with a new one according to the instructions on MGSS (ELECTRICAL SUPPLY UNIT (ESU) REMOVAL/INSTALLATION).

5. Clear the DTC, then turn the ignition off and get out of the vehicle.

- 6. Close and lock the doors.
- 7. Wait for at least 10 minutes.

8. Verify the repair by starting the engine and making sure the Check Engine light is OFF and no abnormal warning lights are ON.

NOTE: If any DTCs should remain after performing DTC deletion, diagnose the DTCs according to the appropriate troubleshooting on MGSS.
