SERVICE INFORMATION

If the following ICC/ADAS codes are stored, make sure to follow the diagnostic procedures in the Electronic Service Manual (ESM) before replacing any parts.

C1A03 – VEHICLE SPEED SENSOR

- The diagnostic procedure in the ESM includes **check and, if needed, repair for ABS DTCs before replacing ADAS components.**
- If repairs are performed for the ABS system; when complete, perform DTC Confirmation Procedure again before doing any additional repairs.

C1A04 – ABS/TCS/VDC SYSTEM

- The diagnostic procedure in the ESM includes **check and, if needed, repair for ABS DTCs before replacing ADAS components.**
- If repairs are performed for the ABS system; when complete, perform DTC Confirmation Procedure again before doing any additional repairs.

C1B01 CAM AIMING INCMP

- The diagnostic procedure in the ESM includes **check and, if needed, repair for LANE CAMERA DTCs before replacing ADAS components.**
- LANE CAMERA DTC may require adjustment of the lane camera.
- If repairs/adjustments are performed for the Lane Camera; when complete, perform DTC Confirmation Procedure again before doing any additional repairs.
