### Correction

If you encounter a vehicle with the above concern, perform the following steps and contact the engineers listed below with your findings.

- 1. Remove the steering column shroud to expose the turn signal bracket and ensure that the turn signal stalk is clipped in on both sides of the bracket. Refer to Steering Column Upper Trim Cover Replacement in SI.
- 2. Can the snaps be engaged? (i.e. are you able to snap the turn signal back into place)
  - If yes, please re-engage the snaps, test functionality and document that the turn signal clips were not fully seated.
  - If no, replace and return the turn signal and Column Electrical Assembly (CEA) bracket that holds the turn signal in place.
- 3. If the turn signal stalk is fully seated within the bracket, please return and replace the full turn signal assembly with the stalk, CEA, and bracket all in one through the normal Warranty Parts Center (WPC) process.
