55 Rear lid operation works intermittently from remote control key

Condition

Customer states:

• The rear lid responds intermittently when using the remote control key.

Workshop findings:

 The rear lid opens and closes properly from the door switch, but only intermittently when double-clicking the trunk release button on the remote key.

Technical Background

The remote control rear lid signal type parameter, stored in the rear lid control module, J605 (address word 006D) is set to press and hold, instead of the double click.

Production Solution

An adjustment to the parameter for the remote control rear lid signal type that is stored in the rear lid control module, J605 (address word 006D) was put into production.
