#### SUBJECT:

6.2L Engine Oil Temperature Sensor Leak

### **OVERVIEW:**

This bulletin involves re-torquing the oil temperature sensor to the provided specification.

### **MODELS:**

2021 (DT) RAM 1500 Pickup

NOTE: This bulletin applies to vehicles within the following markets/countries: North America, LATAM, EMEA and APAC.

NOTE: This bulletin applies to vehicles built on or after July 13, 2020 (MDH 0713XX) on or before April 14, 2021 (MDH 0414XX) equipped with 6.2L Supercharged Hemi V8 SRT Engine (Sales Code ESD).

#### SYMPTOM/CONDITION:

Customers may notice a slight oil leak from under the vehicle near the oil temperature sensor location (Fig. 1).

#### **DIAGNOSIS:**

Using a Scan Tool (wiTECH) with the appropriate Diagnostic Procedures available in DealerCONNECT/Service Library, verify all related systems are functioning as designed. If Diagnostic Trouble Codes (DTCs) or symptom conditions, other than the ones listed above are present, record the issues on the repair order and repair as necessary before proceeding further with this bulletin.

If a customer's VIN is listed in VIP or your RRT VIN list, perform the repair. If any vehicle not on the VIN list exhibits the symptom/condition, perform the repair.

#### REPAIR PROCEDURE:

- 1. Disconnect and isolate the negative battery cable(s). Refer to the detailed service procedures available in DealerCONNECT/Service Library under: Service Info> 08 Electrical / 8F Engine Systems / Battery System / Standard Procedure.
- 2. Disconnect engine wire harness clips to gain access to the sensor wire harness.
- 3. Disconnect the oil temperature sensor wire harness connector.
- 4. Torque the oil temperature sensor to 50 N·m (38 ft.lbs). Do not remove the sensor only torque to the specification provided in this step.
- 5. Reconnect the oil temperature sensor wire harness connector.
- 6. Reconnect engine wire harness clips in place, that were removed to gain access to the sensor wire harness.
- 7. Reconnect the negative battery cable(s). Refer to the detailed service procedures available in DealerCONNECT/Service Library under: Service Info> 08 Electrical / 8F Engine Systems / Battery System / Standard Procedure.
- 8. Check oil level and top off oil if necessary.
