All affected VINs will be flagged "OPEN" in VMI and <b>cannot be sold</b> until remedied.</p>				
<b>Background</b>				
<b>Issue</b>	<p>Mercedes-Benz AG (MBAG), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Mercedes-Benz Metris vans (platform 447/VS20) equipped with an adjustable front passenger seat, certain weld seams on the front passenger seat frame base may not have been manufactured according to specification. If the weld seams on the seat frame base were manufactured outside of specification, the stability of the passenger seat could be impaired which could increase the risk of injury for occupants in the event of a crash.</p>			
<b>What We're Doing</b>	<p>MBUSA is conducting a voluntary recall campaign. An authorized Mercedes-Benz Metris dealer will replace the seat frame base.</p>

If the weld seams on the seat frame base were manufactured outside of specification, the stability of the passenger seat could be impaired which could increase the risk of injury for occupants in the event of a crash.

Prior to performing the campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.

Please note that Recall Campaigns **do not expire** and may also be performed on a vehicle with a vehicle status indicator.
